

- After having served several churches in crisis, and transitioning appropriately as new leadership arrived, I have not had the opportunity to experience a sabbatical. This timing in my life of 15 years in ordained ministry, 5 years at my current call, and my 50<sup>th</sup> birthday all pinpoint a desire
- and need to experience a time of rest, reflection, joy, and delight in considering what do the years ahead hold for me and how do I reshape or invigorate my ministry. After a series of conflicts and crisis, the congregation is at a place of concurrently needing to value and affirm the lay

3. The impetus and origins of considering the value of play began at a CREDO retreat for clergy. Within the 7 days that we were together, the leaders noted a radical difference in our group and identified it as the playfulness of our group. In play, the typical guardedness, positioning, comparing maneuvers that clergy experience all were lowered. In lowering our guards, our depth of healing, authenticity, and intimacy was achieved. It was Plato who said, "...you can discover more about a person in an hour of play than in a year of conversation."

This experience and realization started me on a journey of wondering how vital play is to not only for our well being, biologically, physiologically and psychologically, which have been proven, but also for our well being spiritually. In Matthew, Jesus says that we must become like children to experience and engage the sovereign reign of our God. This is not an excuse to be immature or irresponsible, but we have forgotten what it is like to play. C. Wyatt Runyon seemed to understand this when he said, "We don't stop playing because we grow old, we grow old because we stop playing." In my proposal I am hoping for the following experiences: ♦to observe and engage in play with animals in their natural habitats and environment,

- ♦to observe and participate with professionals who work with wounded or orphaned animals and reeducate them to play again,
- ♦to observe and participate with these experts as they encourage the reengaged animals to help heal humans who have forgotten how to play because of trauma in their lives,
- ♦to integrate these "hands on" experiences of play and its impact on our spiritual development. The experiences I hope to encounter are indeed the most joy filled possibilities I could ever imagine. The components of this experience include the following adventures:

- a. Kayaking with Seals, Sea Otters, and Sea Lions in Monterey, California. The journey begins with the opportunity to encounter and observe these very playful sea animals in their natural California habitat to learn and delight in their play.
- b. The Institute of Play, Carmel, California. While in Monterey, I plan to participate in a workshop (if the 2011 schedule allows) at the Institute of Play and subsequently to have a discussion with founder Stuart Brown, author of the groundbreaking discovery Play, How it shapes the brain, Opens the Imagination, and Invigorates the Soul. The Institute, now nationally recognized and served by many renowned psychologists, psychiatrists, and even Jane Goodall on their board, was developed by accident as Dr. Brown was observing the potential of a husky sled dog being pursued by a ravenous polar bear emerging from hibernation. The reaction of the dog, a playful stance, shifted the bear from consuming the dog to actually playing with the dog. Dr. Brown's hypothesis and since proven theory is that when faced with harm, we have considered either flight or fight in our response, but a third option, play, actually engages a creativity and spontaneity not found otherwise. I believe time with Dr. Brown will provide tools to shape my next experiences.
- c. WildQuest Swimming with Dolphins in Bimini. After a journey home to rest and reflect on this adventure, I will fly to Bimini to participate in a week long educational experience with dolphins. There is noted research on the ability of these marine mammals to teach us in their own encounters of play. It will be a great opportunity to be with them in a non-invasive respectful manner in their world and observe their communication patterns and styles of play. Those who have shared this experience have described it as playful, exhilarating, and healing.

  d. Crystal Peaks Youth Camp, Bend, Oregon. After rest, renewal, and reflection over this adventure, I will travel to Bend, Oregon to Crystal Peaks Youth Ranch, a ranch that rescues

horses that have been abused, neglected, or abandoned. They work carefully to bring healing to these horses by helping them to learn how to play again. The horses, in turn, are used with children and youth who are considered high risk to help teach the children how to play again, to trust, and to receive and extend unconditional love.

e. Africa Adventure. After returning home and finding space and time to reflect, read, and process my adventure, the next exciting leg of the journey is to Africa to share in the opportunity of working with orphaned lion cubs, cheetahs, and other rescued animals. By observing and experiencing lions in the wild and their playful patterns, we can learn much. By working side by side with professionals who work specifically with orphaned cubs, we can experience how these young are retaught to play which is vital to their survival and rerelease to the wild. Several church mission trips have increased my love of Africa, but each time, our exposure to the animals has been limited by time restrictions and financial considerations. This opportunity provides the time and space for realizing this dream. As well, while I am in Africa, I will mark a transition in my life by turning 50. While there, I want to climb Mt. Kilimanjaro.

Flying from Denver to Johannesburg, we would travel by car to Ukutula Lion Park and Lodge (named by the German media as the top 5 animal interaction destinations) and have 4 days of supervised playing with lion cubs. It includes game viewing guided tours of their vast refuge farm, animals that were not able to be released. In my interactions with the director, regarding my proposal with play and animals, he has offered us unlimited time working with the lion cubs. We will drive from Ukutula to Ann Van Dyk Cheetah Centre. This center is well respected for working with cheetahs. We will have a close and "hands on" perspective to their work with these amazing animals.

Leaving Johannesburg and flying into Nelspruit, we will rent a car and drive to Kruger National Park, known for the opportunities to see all the animals of Africa in their natural habitats. We will have 4 days to participate in sunrise and sunset photographic safari drives to specific areas that are home to specific animals. I have been assured by a colleague from South Africa that each of these experiences is life changing.

After Kruger National Park we will fly back to Johannesburg and land in Kilimanjaro.

Traveling with a highly recommended expedition team, we will climb Mt. Kilimanjaro in 8 days, allowing for altitude adjustment and providing ample time to ensure the climb is enjoyable and not overly strenuous. After Kilimanjaro, we will return to Denver.

The last component is Labor Day weekend at a cabin in Aspen with my traveling companions sharing experiences and insights which will help me integrate meaning for my ministry.

#### 4. Intended Benefits for Pastor and Congregation (by Dee Cooper)

The benefits for me, as a single pastor, are the needed balance of rest, restoration, and experiences outside the box of typical ministry demands, to nourish my soul. When I am engaged in ministering to these wonderful people in Evergreen, I am with them 100 percent. This will give me the chance to disengage, reflect on my own roles, and dream of new possibilities. For the congregation, the benefit of stepping into new areas of leadership and ministry in my absence will facilitate growth. As a congregation that is driven with passion, learning to slow down, taking time away and approaching situations from a new perspective, is wonderful community development. I believe they will also thrive while I am gone by the assurance that the success of their ministries and endeavors is not pastor dependant.

# 5. Statement of Intended Benefits for Congregation and Pastor (by Charlene Ray)

As we prepare for her upcoming sabbatical, we, the congregation of Church of the Hills, foresee our beloved Pastor Dee experiencing much needed rest and relaxation. This should result in renewed vitality-both spiritual and physical-and a deepening passion for her call to ministry.

And for us the congregation, we look forward to a *vital renewal* ourselves-a renewed call to Christian service, the opportunity to further our leadership capabilities, and-to serve our church and community in creative ways.

# 6. Coverage for Pastoral Functions (by Worship, Personnel, and Deacon leaders and Dee)

We anticipate engaging three local ministers to fill the pulpit for a month each. We hope they

will incorporate the theme of their series with Pastor Dee's adventures. For the first month, we are in discussion with a local pastor who has expertise in Godly Play. The second month while Dee is in the ocean depths, the preacher could reflect on going deeper into our own spiritual journey, and the last month while Dee is climbing Mt. Kilimanjaro, the theme could be ascending the mountain of God. A monthly congregational potluck/workshop would engage us in this journey of spiritual development through play. For pastoral care, the existing seminary

Moderators for the session meetings would be local pastors. The supervision of staff would be overseen by the personnel team of the church.

## 7. Communication (by Kelly Krueger and Cathy Graves, Communications Team)

intern would be supported and surrounded by our Deacons Board and our Cares Team.

Information shared on a dedicated Sabbatical blog <a href="http://sabbatical.churchofthehills.com">http://sabbatical.churchofthehills.com</a>, the church website, and periodic Facebook postings, will encourage two way communication before, during, and after the sabbatical. Pastor Dee's reading list of resources will also be available for congregants. Pastor Dee will teach a class prior to her departure to inform and engage

congregants of her sabbatical objective. This will not only be helpful to the congregation, but will also inform Dee with relevant questions and insights from the church as she sets off on her time of revitalization. Additionally, a fieldtrip to a nearby animal sanctuary will expose the congregation on the concept of *spiritual development through the power of play*, allowing church members to engage hands-on in the type of study Pastor Dee will be undertaking. Upon her return, a workshop will be scheduled for Pastor Dee to share her experiences and insights and for the congregation to share their successes in lay-leadership, day to day church operations, as well as the "play" experienced by the congregation. From this shared program, should come any cocreated changes within the congregational life and ministries.

# 8. Process (by Rick Bailey, Chair of Personnel and Sabbatical Team)

from the time she was called to be a pastor at Church of the Hills, because a sabbatical during her 5th year of service is a provision in her terms of call, which has been favorably voted on unanimously by the congregation every year since Rev. Cooper was originally called in October 2006. In preparation for the sabbatical, a subcommittee of the Personnel Team has been meeting monthly since January, 2010. As of May, 2010, the committee has accomplished the following:

The congregational commitment to providing a sabbatical for Rev. Cooper was evident

- written a sabbatical policy, which has been approved by the Session,written a congregational letter to announce the plans for the sabbatical,
- \*developed a number of communication channels for keeping the congregation in touch such as mass emails, articles in our internal church publications, sabbatical pages on our web site
  - and blog, and the development of a DVD,
- \*interviewed pastors, in and outside our denomination who have taken sabbaticals and members of their congregations regarding the benefits of the sabbatical time,

\*planned for the coverage of pastoral services, such as preaching, maintaining administrative tasks, and meeting pastoral care needs. This planning involves the Session, the Deacons,

Education, Worship, and Communication Teams.

Although the congregation will miss the presence of our pastor very much, we are excited about the opportunity to experience the preaching and leadership of other pastors and lay leaders. We view this as an opportunity for growth for our congregation.

- 1. Church of the Hills, in its present location for 57 years, was founded in 1953 by 57 members who decided by a difference of two votes to become Presbyterian (USA) over United Methodist. In 1956 the building was completed and dedicated. In 1973 the manse and the Christian education building were dedicated. In 2000 a \$250,000 renovation of the building occurred, and in 2010 an \$80,000 grant updated the technological capabilities in worship and in Christian education. The transitions of many ministers, adding Board of Deacons to the existent Session, and development of fellowship groups have provided depth and strength over the years. Christian education provides intellectual growth for the congregation. Vacation Bible School reached a high mark this past year with 78 children participating and 79 adults and youth
- 2. We have 303 members and worship an average 115 members on a typical Sunday
- 3. The last four pastors have included: Dee Cooper, 5 years; Interim, Patrick Hurley 1.5 years;
- Associate Pastor, Phil Price; 5.5 years; Head of Staff, Kim Skilling 11.5 years.
- 4. There are many opportunities to serve and to be nurtured at Church of the Hills. The Alternative Christmas Fair, initiated and led by COTH members, raised over \$120,000 for non profits both locally and around the world. We have supported Colorado Haiti Project, Kenyan

Children's Foundation, and Friendship Bridge. We see our building as a mission outreach, hosting over 70 meetings a month from outside agencies and non-profits. We serve over 100 people each month at our free community supper. Our children's ministries expand from educational classes, youth group activities, and mission outreaches. There is a warm welcome and a place to call home at COTH and our members make a difference in the larger community as we challenge ourselves to follow Jesus' mandate to GO! Evidenced by the plaque over our sanctuary door that says, "I was a stranger and you welcomed me."

# 2. Ordination, Previous Positions and Tenure of Service

I was ordained June 22, 1996 by the Presbytery of Northern New England. I have served the following congregations: Eliot Presbyterian Church, Lowell, MA, Associate Pastor, for 3.5

years; Grace Presbyterian Church, Wichita, KS, Associate Pastor, 4.5 years; Brentwood

Presbyterian Church, Los Angeles, CA, Associate Pastor, then Acting Head of Staff, 3 years.

#### 3. Information Regarding Ministry Focus and Community Involvement

My ministry at Church of the Hills has focused on re-creating an authentic community environment and healing deep wounds and conflicts among the congregation and staff using both experiential and educational work in relationship skills, communication skills, and conflict

mediation. These relational patterns appear to be systemic and evident in the larger community and I dream that as the church becomes more authentic in their connections, this will transform the larger community of Evergreen. Other Evergreen pastors and I believe that when transformation occurs in a faith community, that community must be motivated to share God's love and grace and laughter in our world. Through the Church of the Hills ministries, I have helped develop programs such as WORKship (a quarterly Sunday devoted to worshipful work in our community), weekly creative (based on an emergent church model) worship services, in addition to our traditional service, and building ongoing relationships with many individuals that have no connections to the church culture. These relationships keep me attuned to what the culture is feeling and experiencing. These various ministries are combined with the traditional preaching, pastoral care, teaching, oversight of programs, and staff supervision which make up my overall roles.

My community involvement has been evident in every location where I have lived. In Evergreen I am an active member of Rotary International, Colorado Haiti Project, the Interfaith Council of Evergreen, and At Home in Evergreen, a 501 (c) 3 organization. I walked 60 miles and 40 miles in breast cancer fundraising walks. Within the Denver Presbytery, I have served on the Committee on Ministry for 5 years and on an Administrative Commission for another congregation in need. I have provided care to many other pastors. I am a member of the Clergywomen's support team. I was selected to attend the Southwest Missional Preaching Academy in California and elected by the Presbytery of Denver to be a 2010 clergy General Assembly commissioner.
